AUTO SELF INSURED CERTIFICATES INFORMATION

Certificates of Self Insured for your vehicles issued as per section 324.171, Florida Statutes, that only covers vehicles, which are owned or leased (Under a lease-purchase agreement) by the name, listed on the certificates. Any other use of these certificates, such as extending coverage to vehicles that are not owned or leased by the self-insurer, may subject you to penalties under the FL insurance Code for unauthorized insurance practices.
